ORDER

**Bearing same No.2779-2783 dated
18.10.2024**

Whereas a society in the name and style of Garhwal Sabha, Faridabad was registered under the Societies Registration Act, 1860 since 1967 and thereafter re-registered under the Haryana Registration and Regulation of Societies Act, 2012 vide Regn. No. 534 dated 27.09.2013 having its registered office at 2C, Badri Narayan Mandir, NIT, Faridabad in the State of Haryana.

Whereas, the election for last Governing Body of the society was conducted in year 2016 and as per byelaws the tenure of the said Governing Body was for a period of 3 years, which expired on 14.05.2019. Since, the society failed to conduct elections of the Governing Body before expiry of its term and due to persisting of litigation for last 5 years, the District Registrar of Societies, Faridabad appointed an Administrator vide order dated 16.08.2019 for the first time to manage the affairs and conduct elections of society. Subsequently, Sh. Yogesh Kaushik, Chief Accounts Officer (Retd.) was also appointed as Administrator vide order dated 21.03.2023, whose services were terminated on grounds of allegations made against him and consequently, the SDM, Badkhal was appointed as Administrator of Garhwal Sabha, Faridabad in place of Sh. Yogesh Kaushik, for a period of 3 months.

In addition to the above, Sh. Ajay Pal Dudy, the Deputy Labour Commissioner, Faridabad was appointed as Administrator of Garhwal Sabha vide Order DRS/FBD/489-491 dated 13.02.2024 but he also couldn't conduct the elections so far and had requested to relieve him of said duties as the officer is unavailable for duties due to administrative reasons.
